**PART 2 – To Be Completed by United States Department of Defense (DOD) Health Care Provider**

Certification to support a request for FMLA covered leave due to a service member’s serious injury or illness includes written confirmation that the service member’s injury or illness was incurred in the line of duty on active duty, and that the service member is undergoing treatment for such injury or illness by a health care provider as listed above.

**If you are unable to provide some of the military-related determinations referenced below, you may rely upon determinations from an authorized DOD representative (such as a DOD recovery care coordinator).**

**Covered Service Member’s Medical Status**

The covered service member’s medical condition is classified as

- (VSI) Very Seriously III/Injured** – Illness/Injury is of such a severity that life is imminently endangered. Family members are requested at bedside immediately. (This is an internal DOD casualty assistance designation used by DOD healthcare providers.)
- (SI) Seriously III/Injured** – Illness/injury is of such severity that there is cause for immediate concern, but there is no imminent danger to life. Family members are requested at bedside. (This is an internal DOD casualty assistance designation used by DOD healthcare providers.)
- OTHER III/Injured** – A serious injury or illness that may render the service member medically unfit to perform the duties of the member’s office, grade, rank, or rating.
- NONE OF THE ABOVE** – Note to Employee: If this box is checked, you may still be eligible to take leave to care for a covered family member with a “serious health condition” under the FMLA, in which case you may need to complete a Certification of Health Care Provider for Family Member’s Serious Health Condition form.
